



RE606 Tilt Sensor is a full-featured security transmitter typically used to sense the tilt of overhead garage doors and windows. It will alarm when the sensor is tilted more than 45 degrees.

Features

Enroll by placing the panel into wireless enrollment mode and then sending an enrollment signal from the sensor. Alternatively, the sensor can be enrolled by scanning its bar code using the Connect+ Installer App or by entering its 8-character serial number on the interactive service provider's web portal.


Sending an Enrollment Signal

- Remove the battery tab and trip the tamper

Install by mounting the sensor to the inside of a door or window using the mounting screw locations. For garage door installations, the sensor should be mounted to the top panel of the overhead door. CE installations must use a cover-securing screw.



Tilt Detection occurs when the sensor exceeds a 45 degree angle. If the sensor rotates further than 135 degrees, it is likely to remain in a non-alarm state. For best results, the sensor should rotate within 90 degrees to ensure an alarm state occurs.



Use the panel installation guide to verify proper system setup.

Pro Tips

3M VHB Tape works great for mounting if the surface is properly prepared and firm pressure is applied for over 10 seconds.

Surface Preparation

- Clean the surface
- Ensure the mounting surface temperature is above 50 °F
